3. Board Updates - Anne

- PSD Board of Trustees created an "Election 2023 Let's talk education" pamphlet to be distributed. It addresses important educational issues, including questions to ask candidates. There is a focus on SGCHS at maximum capacity, provincial funding for long term planning, cross-ministry partnerships, curriculum development, and stability in learning.
- Question about high school planning numbers. Do the estimated numbers submitted for
 planning match the current growth and projections and is there the possibility to alter the
 numbers? Answer: Do not have the numbers on hand. The size of SGCHS has been preestablished and can not be changed. It currently houses about 1000 students and the new
 school will house 1905 students. It is expected to meet the community needs until 2033-2035.
- Question: What will happen with the Horizon Stage? Unsure at the moment what will happen. They will try to destroy the current school while maintaining the Horizon Stage. There are no funds built into the plans to incorporate a new theatre into the new high school that will be government funded. PSD is communicating with the City of Spruce Grove.
