## Grade 9 Off Grounds Permission Form - Lunch Only

Dear Parents and Guardians,

Students in Grades 9 at École Broxton Park School are given the privilege of leaving school grounds during the **lunch hour only** if the proper permission is given by parents, staff and administration. This is a privilege we reserve for students who demonstrate the values of respect and responsibility that Fusion stands for.

Students who go off grounds must be in good academic standing at school, ensuring that their first responsibility is to their course work and having all assignments complete as well as demonstrating punctual and regular attendance. They must also show respect for students and staff in the school, adhere to the code of conduct and demonstrate respect of school property in order to maintain their off grounds privileges. Students who are assigned to an area of the school to complete an assignment or exam during the lunch hour, for example DLR, are not allowed to leave the campus to go off grounds. Students should not return to school property until anything purchased off grounds is consumed. No slurpees or energy drinks will be allowed in the school.

Should a parent/guardian wish to rescind this permission anytime throughout the year please do so in writing to the attention of the school administration. École Broxton Park administration reserves the right to also rescind off school ground privileges should a student not adhere to the expectations above or should proper conduct not be displayed while off school grounds.
